(discuss child support visitation issues) Discuss applicant's health (physical, mental, emotional) assessment and any issues. Discuss any past abuse issues of applicants. How does applicant describe their sexual relationship? Discuss applicant's fertility issues. Where is the applicant in grief process? (this includes single applicants who may be childless) Discuss the applicant's use of leisure time. What are applicant's hobbies, talents? Discuss goals for the future: educational, career and/or relationships.

Describe applicant's stability and quality of interpersonal relationships.... Cite examples of applicant's ability to delay gratification, instances where applicant may have felt unappreciated. How does the applicant apply child development knowledge to parenting?... What about parenting gives them satisfaction? Describe applicant's knowledge of various parenting skills/ techniques and his or her history of practical application of these.... Describe applicant's ability to help children develop positive self-esteem.... Can they use behavior management techniques?... Can applicant discuss positive parenting methods versus punishment methods?... Include applicant's experience or willingness to learn the unique skills needed to parent children with special needs (behavioral, emotional, developmental, physical). What has been applicant's experience with the school system? Does the applicant feel equipped to advocate so the child will receive necessary services?INTERNATIONAL ADOPTIONS: If the adoption study approves the prospective adoptive parents to parent a handicapped or special needs adoption, this fact must be clearly stated per Title 65 Code of Federal Regulations 204.3 (e) (4).

ADOPTIVE OR FOSTER PARENTING

What does applicant hope their family will experience in caring for a foster or adoptive child. Discuss applicant's empathy. Give examples of instances where this has helped or caused problems in applicant's life.... Describe applicant's ability to verbalize what another person is feeling.... Are they able to visualize themselves in the child's or birth parent's place?... Does applicant understand how entitlement issues impact foster and adoptive families? Are they able to verbalize their feelings about parenting another person's birth child?" Do they show evidence of an ability to internalize their rights and responsibilities (limited in foster care but entire in adoption).... Give examples of applicant's ability or inability to maintain long-term relationships and keep promises/commitments even when applicant's quality of life is adversely affected. Discuss support services and how to access those services as a foster or adoptive parent.

PERMANENCY PLANNING

Discuss the process of permanency in child welfare practice and their understanding of a child's experiences of loss and attachment. Discuss how applicant will make a child a part of their family. Discuss the type of care the applicant wishes to provide; short-term (respite, emergency), foster care, foster care with a willingness to adopt or adoption. How has the family prepared themselves to provide this type of care. Is applicant able to realistically anticipate child's future needs or problems? Are they capable of meeting long-term needs of children in care; i.e., commitment? For adoptive and foster families willing to adopt are they willing to continue the parenting role into the child's adulthood, if necessary... Do adoptive parents understand that adoption provides legal bonds and responsibilities? If the family is limited to providing short-term foster care, how has the family prepared themselves to transition the child back home or to a permanent family?

ATTITUDES AND BELIEFS REGARDING FOSTER CARE/ADOPTION ISSUES

Discuss the applicant's ability to meet the special challenges of foster care and/or adoption, including birth parent issues, issues related to commitment and teamwork and his/her ability to work within the guidelines of the child welfare system. Discuss the applicant's understanding of birth parent history and its relationship to a child's identity. Discuss the attachment theory and how multiple moves affect the child's sense of trust, stability, and the child's behavior. Discuss the applicant's willingness to support the child, as a minor or an adult in areas of identity development as an adoptive person.

ABSENT OR PART-TIME CHILDREN

Discuss whether or not diversity issues have caused conflict or problems in the applicant's life and how these were/were not resolved. Discuss how the applicant's cultural awareness may impact the ability to identify and meet any culture-related needs a child may have. Indicate applicant's knowledge of discrimination and comment on the applicant's skills to help children learn to deal appropriately with discrimination, should this occur. Discuss whether or not a child's race would make them targets of discrimination in the applicant's school, community or extended family. If the child could be such a target, indicate how the applicant plans to deal with child safety issues and the source of the discriminatory behavior. Does the applicant understand how to use the knowledge of the child's culture to stimulate development, manage behavior appropriately and to assist the child to meet the demands of daily living? Can the applicant advocate for equal access to services and activities for the child? The use of an assessment tool may be used and attached to this study. Discuss what motivated the applicant to consider trans-racial/trans-cultural placement.... What in the applicant's current lifestyle would support a child's ability to stay connected to their racial or cultural heritage? What changes, if any, to their lifestyle does the applicant foresee in order to meet the child's needs? Include racial and cultural composition of neighborhood, school, community and how the applicant feels this will impact the child, positively and/or negatively.... Can or will the applicant provide adult and peer role models from the child's race/culture? Discuss extent that applicant has thought through becoming a multi-racial and a multi-ethnic family. Include how this will affect others in the home and extended family.

For example, will extended family expect certain rituals or memberships for child? How does applicant intend to meet the child's religious needs? How will conflicts be resolved if the child entering the home has differing religious heritage or practice/beliefs?
