For the Unit 6 assignment, use the job description you created during Unit 4 to help you respond to the questions.

## **Questions**

You are applying for a job as an exempt status night shift supervisor at Home Improvement Center. You currently work at House Plus, but seeing no opportunity to advance, you decided to apply for the job at Home Improvement Center. You have 5 years working at House Plus and meet the minimum requirements as listed in the job description. (Refer to the job description you created during Unit 4.). Currently you have just finished your Business degree with Kaplan online and want to put your knowledge to use.

You e-mailed your resume and received a call for a job interview for Tuesday at 10am. You arranged for time off your day shift at House Plus so you could attend the interview. You arrive on time and the hiring manager calls you into the office.

Fill in the blanks with your own responses. The interviewer is using a series of competency-based interview questions, so be sure to address each part of the question and provide specific examples that clearly demonstrate your ability to perform the required job duties and responsibilities. Use your reading assignment for this week and your own experience to help you respond to the questions. You are also encouraged to conduct your own outside research to help you complete this activity.

## Interview

Hiring Manager (HM) Good morning.
