DISCUSSION POST:

My potential thesis statement is "Insurance companies should reimburse ABA therapy for children on the autism spectrum because ABA is a form of mental health care." Some search terms I can use would be "Applied Behavior Analysis," "ABA insurance coverage," and "ABA and autism." A quick search in the Library reminded me of the importance of limiting search terms and spelling out words, though; the "Applied Behavior Analysis" search yielded over 2.5 million results, and the "ABA insurance coverage" search got me a bunch of articles on the American Bankers Association. I can further narrow my results by limiting the date and asking for only full text articles. Another way to narrow my search is to use specific databases in the library; ERIC focuses on educational issues, and Health Source Consumer also seems like a good idea for this topic.

Using the search term "ABA therapy autism" in the general search bar, I found an article that looks particularly helpful since it focuses primarily on the debate about insurance coverage for ABA therapy. This article was published in *The Journal of Legal Medicine* in 2013, so it is fairly recent and published by a reputable publication. This would be a secondary source since Hansel is drawing upon information from other sources and offering an interpretation of that information (The University Library, 2015). My only concern is that the author is a second-year law student, not a practicing lawyer. Journals are peer-reviewed, however, so I would assume that experts reviewed Hansel's article. I know I will need to evaluate web sites much more carefully; I don't want to pick out a source that is biased or, in the case of a site for an ABA provider, trying to sell a service (The University Writing Center, n.d.).
